6. That the school shall make payment of salary and other admissible allowances to its teaching/non-teaching staff as per ongoing CPC through bank//RTGS.
7. That the school shall submit the copy of latest School Health Certificate issued by MCD within 02 months to the district authority.
8. That the School Authority shall maintain DRF account in the proportionate to the amount charged as depreciation in the balance sheet till date within 02 months to the District Authority.
9. That the school shall comply with the order F.No.DE.15(305)/PSB/Misc./2020/P1 .file-11/5658-5662 dated 21.06.2023 with regard to appointment of Special Educator.
