

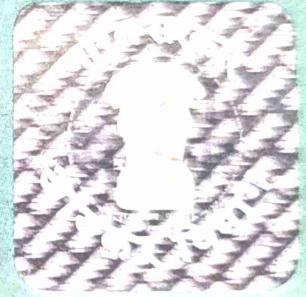

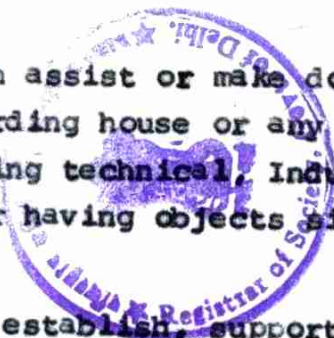
MEMORANDUM OF ASSOCIATION

1. Name of the Society : NATHU RAM MEMORIAL EDUCATION SOCIETY
2. REGISTERED OFFICE : The Registered office of the Society shall remain in the Union territory of Delhi and at present it is at the following address : -

Khasra No. 76, Village Ranholla,  
P.O. Nagloi, Delhi - 110041.

3. AIMS AND OBJECTS : The aim objects for which the Society is established are as under :-

- A. To found, establish maintain, support or subsidise, schools, colleges, pathshalas and other institutions for general education of boys and girls, after getting approval from the competent authority.
- B. To give stipends, scholarship and monetary aids to students and scholars.
- C. To open, found establish assist or make donations or maintain schools, colleges or boarding house or any other educational institutions for imparting technical, Industrial or commercial knowledge or training or having objects similar to those of this Society.
- D. To grant aids, promote, establish, support and maintain institution for the growth, advancement and diffusum of knowledge.
- E. To advance loans to deserving students for persuing their studies on reasonable rates of interest to be repaid by students in convenient instalments or in any other manner as may be decided by the founder or the members from time to time.
- F. To set up instructional or training centres for imparting instruction and training in banking, engineering, commerce, social service, village reconstruction work, small scale industries and such other subjects as may be determined from time to time.

- G. In general to open, found establish, finance, assist and contribute to institutions, commercial, technical or pertaining to fine arts or industries such as workshops, factories and other in institutions for imparting education in workmanship and for providing employment and means of earning adequate wages for the Unemployed and needy.
- H. To borrow or raise money required for executing the aims and the objectives of the society, against bonds, debentures, bills of exchange, promissory notes or other obligations or securities of the society or through mortgage or charge on the society property.
- I. To accept, receive, purchase, take on lease or hire or in exchange or otherwise acquire any lands, buildings, right of common property, immovable which may be required for the purpose of or conveniently used or held in connection with any of the objects of the society and on such term and condition as may be through fit or expedient.
- J. To sell, improve, manage, develop, lease mortgage, dispose off or otherwise deal with all or any part of the property of the Society.
- K. To take such steps by personal or written appeals nonpolitical public meetings or otherwise as may from time to time deemed expedient for the purpose of procuring contributions, to the funds of the society in the shape of donations, annual subscriptions or otherwise.
- L. To purchase or otherwise acquire and undertake all or any part of the property, assets, liabilities and engagements, of any or more of the associations, institutions or societies with which this society is authorised to amalgamate.
- M. To transfer all or any part of the property, assets, liabilities and engagements of this society to any one or more of the associations, institutions or societies with which this society is authorised to amalgamate.
- N. And generally to do all other things incidental to the attainment of the above objects of the society directly or indirectly.

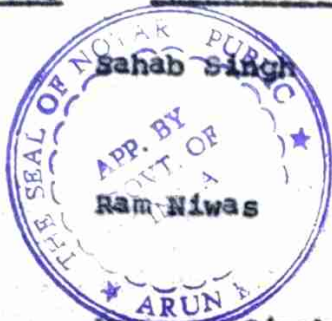

RULES AND REGULATIONS

OF

NATHU RAM MEMORIAL EDUCATION SOCIETY

- 1.0 NAME : The name of the Society shall be NATHU RAM MEMORIAL EDUCATION SOCIETY .
- 1.1 MEMBERSHIP : Every subscriber to the Memorandum of the Society, every member of the Governing body and every person (including bodies corporate, association of persons, Government of Semi-Government authorities) who believe in the aims and objects of this society and whom the Governing body may admit as member shall be members of the society.
- 1.2 SUBSCRIPTION : The rate of subscription for all the members shall be Rs. 501/- payable only at the time of enrolment as a member.
- 1.3 CESSATION OF MEMBERSHIP : A person shall cease to a member of the society by resignation, death disqualification, insolvency or liquidation or for non-attending without taking leave for absence, three consecutive meetings of the General body as the case be. A member shall be deemed to have become disqualified, if in the view of the other member expressed by a resolution of the majority of the total member of the members, he is of unsound mind, of has worked against the aims and objects of the society or has committed an act, which makes it undesirable to have him a member or his membership ceases to be in the interest of the society.
- 1.4 REFUSAL : The Governing body of the society may refuse any person the membership provided the Governing body records the for such refusal.
- 2.1 GOVERNING BODY/ELECTION : The management of the affairs of the society and its investments and the powers of deployment, allotment, payment and the disbursement of it funds and properties shall vest in the Governing body. The Governing body shall consist of not less than 5 and not more than 12 members who shall be elected by the general body of the members of the society. The secret ballot be mode of election.

- 2.2 TERM OF GOVERNING BODIES MEMBERS : The members of the Governing body shall hold office for a term 5 years of the society team the respective dates of their appointment and shall be eligible for re-appointment. Unless otherwise decided by the governing body, a member of the governing body shall continue to be in office after the expiry of his term until his successor has been appointed.
- 2.3 VACANCY OF GOVERNING BODY : In case a member of the Governing body resigns dies, ceases to be a member or vacates office otherwise, the vacancy shall be filled by the governing body by nomination.
- 2.4 POWER OF THE GOVERNING BODY : Without prejudice to the generality of the powers of the governing body to do such things as it may consider necessary or expedient for the purpose of carrying out the objects of the society. The governing may exercise the following powers.
- a) OPEN BANK ACCOUNT : In the name of the society with such Bank(s) or other institutions(s) as it may fit, from time to time, and authorise any two of its members of the society to operate such account(s).
  - b) Defray the expenses of the society activities and make contribution from the funds or property of the society to any other trust or society or association having objects similar to those of the society.
  - c) Invest/deposit such funds of the society as may not be immediately required in such manner as may be determined by board from time to time subject to any statutory restrictions and realise or vary such investments.
  - d) Borrow moneys for the purpose of the society and if necessary, create lien on the society assets for the purpose.
  - e) Appoint and, at the discretion, remove or suspend employees of all categories of the society and, from time to time, determine their power and duties and fix their ~~their~~ remuneration and terms of employment .

- f) Delegate any of its powers (including the power to subdelegate) to such committees or sub-committees and as it may constitute consisting of such members or other, and to any member of the governing body or office bearer of the society.
- g) Sell, improve manage and develop all or any part of the property and rights of the society.
- h) Generally do such things as it may consider necessary or expedient for the purpose of carrying out the objects of the society.

3.1 MEETING OF THE GOVERNING BODY : The governing body shall meet as and when a meeting is convened by the chairman or is requisitioned by at least three members of the governing body provided that it shall meet atleast once in six calender months.

3.2 NOTICE FOR MEETING : At least seven days notice shall be given for a meeting of the governing body, but a meeting may be called by the chairman without any notice in case of exigencies..

3.3 QUORUM FOR MEETING : 1/3rd members of the governing body, personally present, shall form the quorum for a meeting of the governing body.

3.4 DECISIONS : The governing body shall take decisions by a vote of the majority. Every member shall have one vote and in case of a tie, chairman of the meeting shall also have a casting vote.

3.5 RESOLUTION BY CIRCULATION : A resolution by the majority of the members of the governing body after circulation amongst all the member for the time being in India, shall be an effective and binding as resolution passed at a meeting of the governing body.

4.1 OFFICE BEARERS : The society shall have the following office bearers

1. President
2. Secretary
3. Treasurer
4. Executive Members Minimum four ( Maximum Seven )

The president of the society shall be the president of the governing body and Vice-versa. All the office bearers of the society shall be elected in the General body meeting.

5.1 The office bearers as specified in clause 4.1 shall have the following powers/functions.

PRESIDENT : He shall preside overall the meeting of General body and governing body.

In case of equality of votes in any meeting he shall have a casting vote.

He shall supervise work of other office bearers.

SECRETARY : He shall represent the society. He shall keep and maintain all records including the register of members, minutes books etc,. He shall undertake all types of correspondence. On behalf of the society. He shall convene the meetings of General body and shall also inform every member regarding the times, date place etc, of the meeting . He shall perform all other function as may be assigned to him.

TREASURER : He shall collect subscriptions, gifts, grant aids donations etc, from the members, general public and he shall also be responsible for ~~member's~~ keeping and maintaining of a due and correct of the society.

6.1 FINANCIAL YEAR :: The account of the society shall be made up and prepared from 1st April to 31st March, every year.

7.1 AUDIT : The Society annual accounts shall be AUDITED by any Chartered Accountants appointed as auditor of the Society.

8.1 There shall be a general body of the society consisting of all the members of the society. The meeting of the society's general body shall be held atleast once in a financial year. 1/3rd members shall be the quorum. No quorum shall be required in the adjourned meeting.

An emergency meeting of general body may also be summoned on the written request of 3/5th members. A minimum notice of seven days shall be required to convene the meeting of general body.

Following business shall be transacted in these meeting. The decision shall be taken by a simple majority.

1. To prepare annual programme and policies.
2. To pass annual budget of the society.
3. To discuss and to decide all such other matters and issues which are directly or indirectly related to the affairs of the society.
4. To appoint an auditor who will annually inspect of the accounts of the society's fund.

8.2 EXTRA-ORDINARY MEETINGS : An extra-ordinary general meeting of members requisitioned by members sufficient in the number to constitute a quorum.

8.3 The provision applicable to governing body shall apply mutatis mutandis to general meetings.

9.1 ANNUAL LIST : Every year a list of governing body office bearers and members shall be filled in the office of registrar of societies Delhi as required U/S 4 SR Act, of 1860.

10.1 AMENDMENT : Any amendment in the memorandum of rules this society shall be carried out in accordance with procedure laid down U/S 12 and 12A of SR. Act, of 1860.

11.1 LEGAL PROCEEDINGS : The society may sue or be sued in the name of its president as required U/S 6 of Sr. Act, of 1860.

12.1 INCOME NOT TO REVERT : The income of the society from its Property of donations, whatsoever derived shall be applied solely towards the promotion of the objects of the society as set out in its Memorandum of association and no portion there of shall be paid or transferred directly or indirectly to the persons who at any time are or have been members of the society or to any of them or any person claiming through any of them provided that nothing herein contained shall prevent the payment in good faith of remuneration to any person (including a member of the governing body) called upon to perform some office or function for the society.

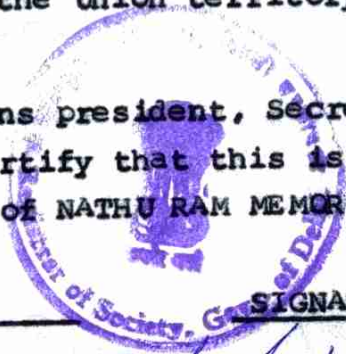
